### **TERMS AND CONDITIONS:**

#### **General**

These 'Terms and Conditions' ('Rules') apply to any competition (the 'Competition') that is promoted on the Matthews.ie website, this website is the property of Matthews Coach Hire Limited of Callenberg, Inniskeen and by entering the Competition, you agree to be bound by the Rules.

In the event of any dispute regarding the Rules, the conduct or results of the Competition, or any other matter relating to a Competition, the decision of Matthews.ie shall be final and unchallengeable and no correspondence or discussion shall be entered into, comment issued, or reason given in respect of any decision made by Matthews.ie

#### **Competition Entrants:**

By entering the Competition, you hereby warrant that all information submitted by you in your Entry is true, accurate and complete in every respect. Matthews.ie reserves the right to verify any information contained in your Entry and/or your eligibility to enter the Competition.

Unless otherwise stated in the Competition Terms, the Competition is only open to persons who are resident in the counties Louth, Meath and Monaghan and persons who are resident outside of these areas may not apply at this time.

Matthews.ie reserve the right in its absolute discretion to disqualify any entrant if it has reasonable grounds to believe that an entrant has breached any of the Rules, any applicable law (including copyright law) or has otherwise infringed the intellectual property of any other person.
